CASTING POND RULES

ALL ENTRANTS MUST USE THE CASTING EQUIPMENT SUPPLIED BY THE TORONTO SPORTSMEN'S SHOW.

ALL CASTING TO TAKE PLACE FROM THE CASTING DECK ON THE SPECIFIED SPOT.

TORONTO SPORTSMEN'S SHOW STAFF WILL REMOVE THE DISK RETRIEVED BY THE PARTICIPANT AND AWARD THE RELATED PRIZE.

THE FIRST 10 PEOPLE RETRIEVING A FINALIST DISK WILL QUALIFY TO TAKE PART IN THE \$20,000 CAST-OFF TO BE HELD AT THE CASTING POND **SUNDAY, March 22nd, 2020 at 3:00 P.M SHARP!** NO GRACE PERIOD. ANY QUALIFIER NOT PRESENT AT 3:00 P.M. WILL BE DISQUALIFIED.

CASTING ORDER OF THE FINALISTS FOR THE \$20,000 CAST-OFF WILL BE IN THE ORDER POSTED.

TWO CASH PRIZES IN THE AMOUNT OF \$20,000 WILL BE PAID OUT TO THE FIRST TWO FINALISTS THAT SUCCESSFULLY CAST THE RUBBER PRACTICE PLUG INTO THE OPENING OF THE TARGET TEMPLATE ON THE FLY. THE PRACTICE PLUG, ONCE CAST, MUST STAY ATTACHED TO THE FISHING LINE AND GO COMPLETELY INTO THE OPENING IN THE TARGET TEMPLATE AND STAY INSIDE.

PRACTICE CASTS ARE NOT PERMITTED. THERE WILL BE A FAMILIARIZATION OF THE EQUIPMENT BEFORE THE CAST- OFF COMMENCES.

THE CONTESTANT WILL HAVE ONLY ONE ATTEMPT TO SUCCESSFULLY MAKE THE CAST. AN ATTEMPT HAS OCCURRED WHEN THE CONTESTANT HAS CAST THE PRACTICE PLUG.

EACH OF THE 10 FINALISTS MUST EXECUTE A FINALIST AFFIDAVIT & RELEASE PROVIDED BY THE TORONTO SPORTSMEN'S SHOW, TO PARTICIPATE IN THE \$20,000 CAST-OFF. ANY CONTESTANT NOT EXECUTING THE **FINALIST AFFIDAVIT & RELEASE** WILL NOT QUALIFY TO PARTICIPATE IN THE \$20,000 CAST-OFF.

FAILURE TO OBSERVE ANY OF THE ABOVE TERMS WILL DISQUALIFY YOU AS A CONTESTANT AND NO PRIZE AWARDS WILL BE CONSIDERED.
